#### Why is this webinar important to me?

The purpose of this session is to show examples of records with great genealogical significance that are held by the National Archives in their original format, usually paper, that have not been microfilmed or digitized. These kinds of records are not widely known by genealogists because they are not available on their home computers nor are the images available on microfilm held by libraries or other repositories close to their homes. In addition, the main descriptive catalogs of the National Archives, available online on the National Archives website (www.archives.gov), require some instruction to use, and interpret results, effectively. These databases are not yet at a place where searching for personal names will yield comprehensive results. This means that many genealogists do not know about Federal records that could be important to their family history research even though the availability of the records has been announced on the worldwide web. That means that a large number of valuable records, crucial to the research of genealogists, are not being utilized by genealogists in the various reading rooms of National Archives.

#### What is the purpose of this session?

Obviously, it is impossible to show all ten billion documents held by the National Archives repositories in one webinar. The hope is that genealogists who participate in this session will gain a wider perspective of resources that are available to them to assist in their research. The intended purpose of this session is to generate questions and inquiries from genealogists about the records of the National Archives by showing examples of some of the records that could be used for genealogical research.

#### If I have questions or want more information who should I contact?

This handout contains the names and contact information for all of the National Archives repositories throughout the country. If you know what records you are looking for, and you know which repository holds the records, you can contact them directly to make your inquiry or request. If you have a general question, you see something in this webinar you would like to know more about, or you seek Federal records but don't know how to get what you need, you can contact the National Archives at Riverside. Staff there will be happy to assist you.

Allow at least three weeks for NPRC (MPR) to receive your request, process it, and retrieve the related record.

Jewish Genealogy 101

The Southern California Genealogical Society (SCGS) launched its Jamboree Extension Series (JES) webinars in March 2011. SCGS was the first genealogical society to offer regularly scheduled webinar sessions, and the popular series will continue through 2012.

The series was developed to fulfill SCGS's mission to share genealogical information; to deliver membership benefits to SCGS members who live outside the LA area; to help researchers from around the globe; and to spread awareness of SCGS and Jamboree.

In 2011, we reached genealogists from 48 US states and 7 Canadian provinces, as well as England, Wales, Ireland, France, United Kingdom, Algeria, Uganda, Australia, New Zealand and Israel.

## What's a webinar?

Don't be daunted by the name. A webinar is an educational class. (That's the "-inar" part, as in the word "seminar.") It's led by a professional or specialist in the topic and is delivered over the Internet. (That's the "web-" part.) Speakers typically provide a handout or article to accompany the slideshow. Sessions include a Q&A period and some include special offers or drawings for door prizes.

## How much does it cost?

The live broadcast of each session is open to the public and FREE to all everyone (space is limited to 1000 attendees). Webinars are recorded, archived, and available for the next twelve months, day or night, in the members-only section of the SCGS website. A one-year individual membership costs only \$35 and affords access to all JES webinars. That's right. SCGS Members have 24/7 access to the archived webinars.

## How do I sign up?

#### Step 1

The link will take you to an registration page. Enter your name and email address and answer a couple of questions. You will get a confirmation of your registration. You'll also receive reminders before the webinar. The reminder email will have information on accessing the handout material.

#### Step 4

On the day of the session, click the link that you received in your invitation to GoToWebinar.com for your session. You may also phone in to the session and listen to the presentation. You won't be able to see the screen but you will be able to hear the speaker. Long distance charges may apply.

## How do I watch a webinar?

To watch the speaker's material and listen to the presentation, you will need computer equipment with speakers and a broadband Internet connection.

Review the technical requirements to verify whether your computer will work to watch the webinar. If you have broadband (DSL or cable) you will have a much better experience.

Technical requirements include: PC-based attendees Required: Windows<sub>®</sub> 7, Vista, XP or 2003 Server Macintosh<sub>®</sub>-based attendees Required: Mac OS<sub>®</sub> X 10.5 or newer

Although most people use their computer or iPad to see and hear the presentation, it is possible to listen to the discussion by phone. Telephone attendees won't be able to see the presentation but will be able to listen.
